The Club's New Name

Here is a summary of the vote:

At the November club meeting, a vote was taken to change the club name. In debate of the motion, an amendment by substitution was made and passed (by raise of hand) to amend the motion to read as follows:

"RESOLVED, that the following amendment to Article I of the Articles of Incorporation of the Men's Garden Club of Minneapolis, Inc., a Minnesota nonprofit corporation, be hereby amended to read as follows: ARTICLE I

The name of this corporation is Men's and Women's Garden Club of Minneapolis.

BE IT FURTHER RESOLVED, that the President and Secretary of this corporation be hereby authorized to certify to this amendment to the Secretary of State of the State of Minnesota."

The motion passed on a secret ballot of 30 votes yes, to 24 votes no.

Voting was conducted according to Article II, Section 6 of the MGCM Bylaws, which says "... any motion before the membership shall carry when the greater of: two thirds of a quorum, or a majority of those present, votes for it."

The current membership stands at 81, so a quorum is 33 (40%) and minimum of 22 yes votes were required (with yes votes also needing to be the majority).

The recording of this change will take place soon. It is anticipated that a proposed change of the by-laws will take place in 2013 to incorporate the new name. It has also been suggested that the by-laws be amended to more explicitly state the procedures and voting requirements to amend the Articles of Incorporation, such as enacting a name change, as this was a source of confusion and contention with the present vote.

Scholarship Committee Report: Recipients Selected, Challenge Set

The Scholarship Committee met Oct. 22nd at the Masonic home where Jan Johnson was recovering from her surgery. Present were Merle Pulley, John Sims, Maury Lindblom, Jan Johnson, Andy Marlow and Kent Petterson. The committee was informed that Jan Johnson has issued a challenge to the club for donations to the Scholarship dedicated fund. Between now and the end of the year all member donations up to \$500 will be matched by her with a donation of an equivalent total amount of \$500. This will be announced in the *Spray* along with a general request based on our status as a 501c3 organization. This is once again fabulously generous donation and we thank Jan for her continued support.

The following candidates were clearly preferred on the committee as meeting our club requirement of students to have future potential in roles that will be consistent with the needs of our gardener members. The Club Board has approved the committee recommendation of \$1000 scholarships for the following three students and they have been invited to our annual Holiday Party in early December.

Bernadette Emery is from Stanton Minnesota and is a second year student at Dakota Technical College in Greenhouse Operations and Design. She is a hands-on gardener who would eventually like to own her own greenhouse business.

Sandy Romsdahl is from Dalbo Minnesota and a first year student at Anoka Technical College in their Landscape and Nursery Technology Program. Sandy is a church garden club member and wants to have her own greenhouse/ cut flower business.

Jodi Refsland is from Minneapolis Minnesota and after completing undergraduate work at the University of Minnesota is currently a first year graduate student in the University's Master of Landscape Architecture curriculum. Jodi has had significant experience in hands on gardening at Vintage Garden Horticultural Services and worked in the Gulf Coast after Hurricane Katrina. Her career interests include teaching restoration ecology.

Meeting Minutes: MGCM Annual Meeting

November 13, 2012

Pres., Robert Kean called the meeting to order at 7:13 Guests were introduced including Welby Smith, a local garden author. Doug Whitney was presented with his honorary membership certificate. He accepted the honor with humility. The nominated officers for 2013 were introduced: President – Sandra Abraham Vice-President – Randi Larson Recording Secretary – Laurie Levin

Recording Secretary – Laurie Levin Co-Treasurers – Nancy Bjerke and Margaret Hibbard Membership Secretary – Jean Strande Past-President – Robert Kean Directors – Don Trocke, Judy Brooke, Nancy Bjerke/Margaret Hibbard

Andy moved that nominations be closed and a unanimous ballot be cast for the slate. Seconded and carried.

Three \$1000 scholarships were announced. The winners will be introduced at the Holiday Party. A \$500 matching grant was also announced. Donations need to be made by December 31, 2012.

A quorum was present, so a vote on the name change resolution could proceed. Andy Marlow moved to accept the resolution as mailed. Seconded. Discussion – Someone asked that the resolution be read. The name would be the Metro Garden Club of Minnesota. Rules for discussion and voting were read. Comments pro and con were accepted. In order to change the name the Articles of Incorporation must be changed first and then the By-laws can be changed at a later time. The Articles are the legal status of the club and the By-laws denote the internal working of the group.

Andrea Green moved to amend the resolution to read "Men's and Women's Garden Club. Seconded by Carol Ann Brekke. Larry Larson moved to add "Minneapolis" to the name. Andrea agreed to the addition. Gary DeGrande seconded the motion. Thirty-one votes approved the change in the resolution. The new name replaced the original one and was voted on. Fifty-four voted were cast – 30 yes and 24 no. The name change resolution carried as amended and the name has been changed to the Men's and Women's Garden Club of Minneapolis.

The business meeting was adjourned at 8:40. The program on garden books began.

New Business: The catering committee recommended we keep the current caterer, Mark Heder. Cost will be determined soon.

December Board meeting – New Board members will be invited to the meeting on Dec. 3. Jan will bring treats.

Rookie of the year: Several names were suggested. An e-mail vote will be made. Tom McKusik will sit at check in table to encourage membership in the Horticulture Society.
